PLEASE NOTE:

The MGSS Board shall be accepting Applications for qualifications at MQF Level 7 (Full Time, Part-Time or Distance learning) provided that in the case of Masters Degrees ONLY, results are published after 31 October 2015. The Board accepts also applicants who have commenced their studies, provided that in such cases results are published during 2015 or after. If awarded a scholarship, the Applicant is eligible for funding for the remaining period commencing from date of publication of rankings.

The MGSS Board accepts applications for MQF level 8 (Doctorate) studies (Full Time, Part Time or Distance Learning). The Board accepts also applications for Doctoral studies which commenced prior to 1st January 2014, provided that in such cases results are published during 2015 or after. If awarded a scholarship, the Applicant is eligible for funding for the remaining period commencing from date of publication of rankings.

If you wish to apply for Masters (Full Time, Part Time, Distance Learning) whereby results are published by 31 October 2015, please apply under MASTER it!.

Each candidate must complete this form (*either typewritten or written legibly in blue ink*). The Application Form contains seven (7) pages including three (3) Appendices. Each applicant has to submit one (1) application form. The applicant is also required to submit one (1) original copy of the 3 Appendices and three (3) copies of the mentioned Appendices.
